

ETCMC V2 TERMS AND CONDITIONS

Version 2.0 | Effective January 2026

1. Acceptance of Terms

1.1. Automatic Binding Agreement: These Terms and Conditions ("Terms") constitute a legally binding agreement between you and the Ethereum Classic Mining Community V2 ("ETCMC V2"). By accessing the website (www.etcmc.org or associated domains), downloading or using ETCMC V2 software, purchasing products, or interacting in any way with the **ETCMPOWv2 Token** or related smart contracts, you automatically acknowledge that you have read, understood, and agree to be bound by these Terms.

1.2. Scope of Application: These Terms apply to all services, content, products, software, and blockchain interactions provided by or associated with ETCMC V2.

2. Eligibility

2.1. Universal Requirement: You must be at least the age of majority in your jurisdiction to use any ETCMC V2 services, interact with the ETCMPOWv2 token, or operate node software. By interacting with any part of the ETCMC V2 ecosystem, you represent and warrant that you meet this age requirement and have the legal capacity to enter into this agreement.

3. NO REFUND POLICY

3.1. All transactions within the ETCMC V2 ecosystem are final. This includes, but is not limited to, the purchase of hardware, software licenses, NFT licenses, token swaps, and service fees. ETCMC V2 does not issue refunds, credits, or exchanges under any circumstances once a transaction has been initiated or a product/license has been delivered.

4. Software, Nodes, and Licensing

4.1. Mandatory Registration: Users must register their nodes with accurate information, including:

- Username: (License ID Number)
- Email: (User's choice)
- Wallet Address: The specific ETC wallet address used for the initial purchase or associated with the NFT license.

4.2. Single Device Policy: Each NFT license is valid for use on a single device only. Unauthorized deployment on multiple devices or virtual environments is strictly prohibited.

4.3. NFT Ownership & Rewards: Users must hold the valid NFT license in their registered wallet address until rewards are distributed. If an NFT license is listed on a marketplace or transferred, the user is no longer the owner and forfeits all rights to rewards associated with that node.

4.4. Prohibited Acts: Tampering with, decompiling, reverse engineering, or attempting to exploit the software or smart contracts is strictly forbidden. Any such activity will result in a permanent ban and the immediate revocation of all associated licenses and rewards.

5. Token and Staking Requirements

5.1. ETCMPOWv2 Staking: To be eligible for claims or rewards, users must meet the minimum staking requirements in ETCMPOWv2 as defined by the current Staking Smart Contract parameters. Failure to maintain the required stake may result in the inability to claim rewards.

5.2. Token Risk: Interaction with blockchain tokens involves significant risk. ETCMC V2 is not responsible for market volatility or loss of funds resulting from user error or smart contract interactions.

6. Intellectual Property

All original content, logos, software code, and brand elements are the exclusive property of ETCMC V2 and are protected under international intellectual property laws.

7. Liability and Warranty Disclaimer

7.1. "As Is" Basis: All services, software, and tokens are provided "as is" and "as available" without any warranties of any kind, either express or implied.

7.2. Limitation of Liability: ETCMC V2, its operators, and contributors shall not be liable for any damages—including but not limited to financial loss, data loss, or hardware failure—arising from the use or inability to use the services or interactions with the ETCMPOWv2 token.

8. Governing Law and Jurisdiction

8.1. Jurisdiction: These Terms shall be governed by and construed in accordance with the laws of the United Kingdom.

8.2. Dispute Resolution: Any dispute arising out of or in connection with these Terms shall be referred to and finally resolved by arbitration under the rules of the London Court of International Arbitration (LCIA).

9. Modifications

ETCMC V2 reserves the right to modify these Terms at any time. It is the user's responsibility to review these Terms periodically. Continued interaction with the ETCMC V2 ecosystem following any changes constitutes acceptance of the revised Terms.
